## 2025 SCHOLARSHIP APPLICATION PROCEDURE

**NOTE:** *Applications must be submitted directly to PinkRose<sup>SM</sup> Foundation, Inc., and all decisions of PinkRose<sup>SM</sup> Foundation, Inc. are final and binding.*

**Eligibility Requirements:** Eligibility is limited to individuals who are legal residents of the United States of America, under the age of 25, who have lost a parent or legal guardian to breast cancer. Applicants must have a high school diploma or equivalent. Applicants must be pursuing post-secondary education or certificate training.

### **Written Statement**

A written statement must be submitted with your Application. In your statement, you should address the topics outlined below. Please include your name and the name of your deceased parent in the right-hand corner of the pages of the statement. This statement should total two pages and include a picture.

1. Autobiographical information describing the significant impact of breast cancer on your life. Also, describe how your academic motivation and interests, professional and volunteer experience, and career objectives were altered. Include a summary of your principal interests and activities. Please highlight community and service-oriented activities. Note when you have held leadership positions.
2. A detailed statement of intent articulating your interest in the PinkRose Scholarship. Please explain how obtaining a post-secondary degree or certificate will benefit your future by helping fulfill your goals and dreams.

### **Applicant's Agreement**

If I receive a [PinkRose<sup>SM</sup> Foundation, Inc.](http://www.pinkrose.org) Scholarship, I agree that:

1. I am responsible for gaining admission at my selected institution and if my scholarship has been approved by PinkRose<sup>SM</sup> Foundation, Inc. Selection Panel then I will use my scholarship only at my selected institution;

## 2025 PINKROSE SCHOLARSHIP TERMS AND CONDITIONS OF PARTICIPATION

To be eligible to participate and be considered for a PinkRose Scholarship, your (“Applicant”) Application must be accompanied by a signed and dated Acknowledgment.

### **Terms and Conditions of Participation:**

1. No purchase Necessary. Open to legal residents of the 50 United States, and/or the District of Columbia, who are at least 18 years of age and under 25 years of age, and who have lost a parent or legal guardian to breast cancer. To submit a Scholarship Application, please complete the current PinkRose Scholarship Application. No Applications will be considered without a completed Application and a signed Acknowledgment, signifying your understanding and agreement with these Scholarship Terms and Conditions of Participation. Send the Application, written essay, this signed Acknowledgment, a copy of your parent’s or legal guardian’s death certificate with breast cancer identified as the cause of death, a copy of your birth certificate, and proof of enrollment in your selected institution (collectively referred to as “Application Materials”) to the following address: *PinkRose<sup>SM</sup> Foundation, Inc. P.O. Box 1527, South Dennis, MA 02660.*
2. PinkRose Foundation directors, employees, and their immediate families may not participate in this Scholarship Program. Applicants submitting the Application Materials must be acting on behalf of, and if necessary, with the consent of a legal guardian. Applicants must provide current contact information to be notified if their Application is selected and they are awarded a PinkRose Scholarship for either the calendar or academic year following the calendar year that the Application was submitted (as determined by PinkRose<sup>SM</sup> Foundation, Inc. in its sole discretion).
3. All PinkRose scholarships are valid for up to the total scholarship amount identified in the formal notice of PinkRose Scholarship award from PinkRose<sup>SM</sup> Foundation, Inc.. PinkRose Scholarship awards are valid only for the calendar or academic year following the calendar year that the Application Materials were submitted and cannot be carried on to subsequent calendar or academic years. Applications for each PinkRose Scholarship award period are accepted during the period beginning on May 15th and ending on October 31st of each calendar year. PinkRose Scholarships shall be awarded during December of each year and are valid for the following calendar year only. For each annual enrollment Application period as defined herein, all Applications must be received not later than 5:00 PM EST on October 31<sup>st</sup>, however, if such day falls on a non-business day, then applications will be received until 5:00 PM EST on the first business day following October 31<sup>st</sup>. A panel of judges selected by PinkRose<sup>SM</sup> Foundation, Inc. will review Applications, whose decision on all matters shall be final. PinkRose Scholarship recipients will be notified during the month of January by the means specified in these Scholarship Terms and

4. Applicants who have been selected to receive a PinkRose Scholarship will be notified by e-mail. Odds of being selected for a PinkRose Scholarship depend upon the number of valid Applications received. Recipients will be posted at the PinkRose Website within 30 days of selecting all of the recipients for that year. Winners may be asked to submit a short biography and/or photograph of himself/herself that will be posted to the PinkRose Website.

5. Only one Application per Applicant. Except where expressly prohibited by law, participation in the PinkRose Scholarship Program represents your express acknowledgment and agreement that PinkRose<sup>SM</sup> Foundation, Inc., their parent, subsidiary, or affiliates, may print, reprint, publish, advertise, promote and/or otherwise exploit, in any medium, the Application Materials (excluding the Applicant's birth certificate and parent's or guardian's death certificate) submitted pursuant to this Scholarship Program, without any payment or consideration to the Applicant or anyone authorizing Applicant's use of any of the Application Materials. Selection of applications for the PinkRose Scholarship will be done annually based upon the panel's determination and may include selection on a first come first served basis, best essay, and/or other non-discriminatory means as selected by the panel, in the panel's sole discretion.

8. The amount of each PinkRose Scholarship and the total number of PinkRose Scholarships granted depends upon the funds available and a number of applicants on a year-to-year basis. PinkRose<sup>SM</sup> Foundation, Inc. reserves the right in its sole discretion to establish the PinkRose Scholarship amounts and number of PinkRose Scholarship awards in each calendar year, if any. Award of PinkRose Scholarships are limited and Applicants may only receive up to one PinkRose Scholarship per calendar year. PinkRose Scholarships are not transferable, may not be substituted and may not be redeemed for cash. Any and all applicable federal, state, and local taxes, as well as any other taxes, fines, fees, or the like, are the responsibility of the PinkRose Scholarship recipient; however, there are no fees due to PinkRose<sup>SM</sup> Foundation, Inc. for participating in the PinkRose Scholarship Program.

The PinkRose Scholarship recipient may be required to sign an affidavit of eligibility and/or a liability release.
